

## ***Robert Daniel Jackson Scholarship Fund***

Robert Daniel Jackson, generally know as “Danny” lived in Piscataway, NJ for 77 years. Danny served his community as part of the Senior Citizens Advisory Commission, Piscataway African American Senior Club, Piscataway Historical & Heritage Society Inc., Piscataway Township Civil Rights Commission and was appointed Board Member by the Local Board #31 New Jersey Selective Service System. He was also a founding member of the Piscataway Memorial Post #7504 VFW.

Most of Danny’s time and energy was devoted to the fire service. Dan was a chartered member of the Holmes Marshall Volunteer Fire Company which was founded in 1954. He served as the Fire Commissioner Piscataway Township District #2, for thirty years, and served as the Vice Chair of the Piscataway Township Relief Association. Dan was a member of the New Jersey State Exempt Fireman’s Association, The New Jersey Volunteer Fire Chief’s Association, International Association of Fire Chiefs and a life-time member of the New Jersey State Fire Chiefs Association.

Danny was extremely dedicated to serving his community, if you believe that you betray some of these qualities please apply for the scholarship that has been established in his honor.
